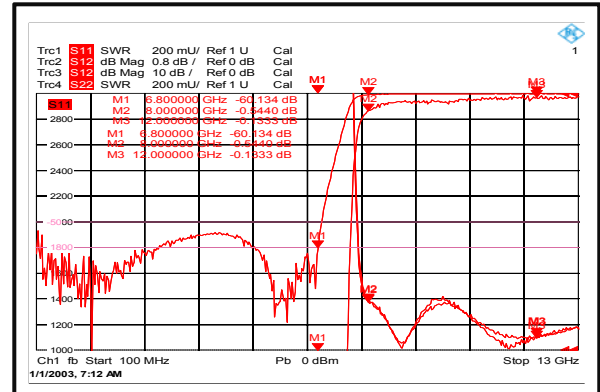

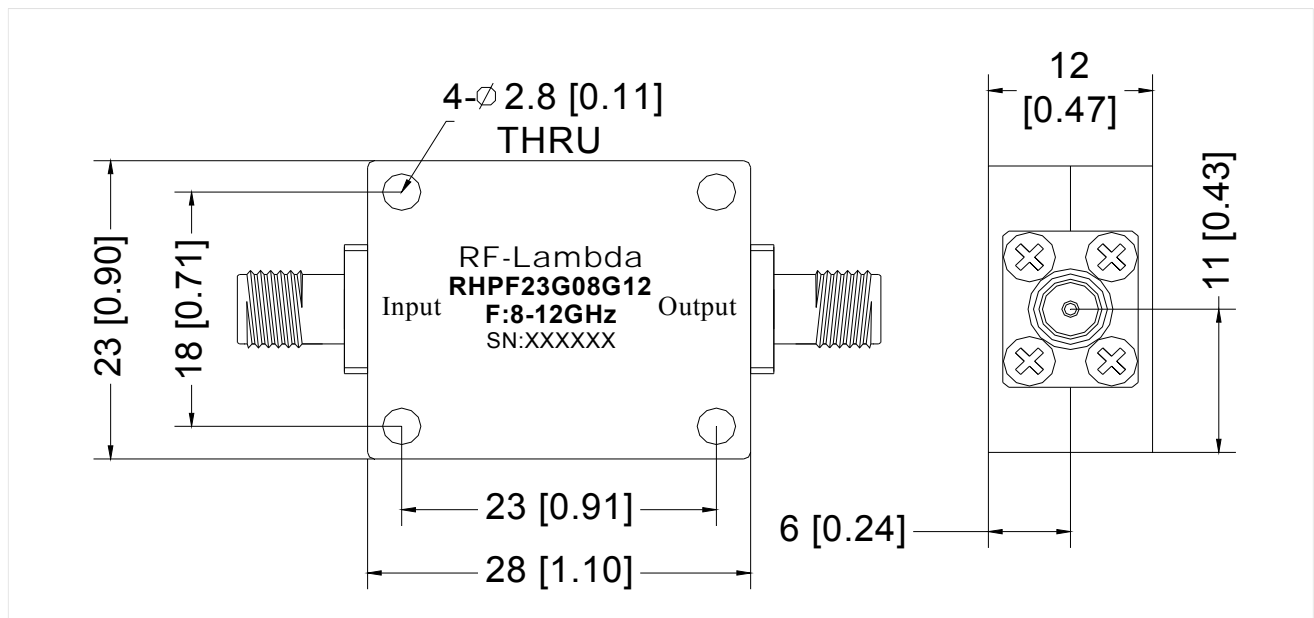
Typical performance plots
